Tim Berry, Auditor of the State of Indiana June 22, 2010



Indiana Auditor Tim Berry discussed the state spending and revenue statistics on Tuesday. Total tax revenues are down more than \$1 billion from May 2009 estimates. In response to the budget revenue shortfall, the state reduced the number of state employees, freezing wages, among other measures. According to Berry, the state has maintained fiscal “integrity” while other states’ credit ratings have plummeted: Indiana is one of only nine states having a AAA bond rating.

The state generates the majority of its revenue from state sales tax, income tax and corporate income tax. All three revenue areas are down significantly; the state revenue received for 2010 is below the revenue figures received in 2005. Berry did express optimism that state sales tax revenue is on the rebound, noting that it has grown in two of the past three months.
